- 1. Apologies were received from Diana Evans and Vicky Knocker for personal reasons.
- 2. Minutes of the Council meeting held on 20th October 2025 were approved and signed.
- 3. There were no declarations of interest in respect of any agenda item.
- 4. Matters arising -

There has been no response to a request for Speedwatch volunteers and no residents wished to meet with Leo Hammond. Therefore a visit will not be arranged at the moment. The speed policeman sign has been in action.

When the dates of Annual Village Events in 2026 are confirmed the website will be updated.

- 5. Finance Penny confirmed the bank balance which was agreed. Pocklington Ramblers have offered a donation for car park use. It was agreed to purchase a new laptop. The following payments were agreed:

- 7. Huggate Quarry

 - f) The crocodile teeth and the top of Silver Street road markings have not yet been repainted. Penny to contact ERYC again.
 - g) The Annual Village Summer Fair will continue to be based at the church. The parish council will offer assistance once the date is confirmed

- h) Jane will clear the pond throwline of vegetation
- i) The pond level is very high, Penny will report this to ERYC
- j) The car park surface has been damaged by vehicles and may need raking in the spring
